## **Directory Exclusion Request and Authorization**



Any student who wishes his/her directory information to be unlisted must submit a written request to the Registrar. Current students will complete and submit this form advisably within 14 days from the start of classes for Directory Information to be excluded. Completed forms must be presented in person, with appropriate identification, or mailed. Requests received by mail must be notarized or they cannot be processed.

Under the provisions of the Federal Family Education Rights and Privacy Act of 1974 (FERPA), Colleges may disclose information about a student designated as "directory information." This information can, by law, be released to the general public and may be listed in the campus directory. SUNY Cortland has designated the following as Directory Information:

- Name
- Permanent address
- Telephone numbers
- SUNY Cortland e-mail addresses
- Local telephone number as listed in Campus Information Directory
- Local Address as listed in Campus Information Directory
- Individual photograph or electronic image
- Class standing
- Age in years

- Academic major
- School of study
- Dates of attendance
- Degree(s) earned
- Honors, awards, special recognitions, scholarships
- Participation in officially recognized college activities, events, and sports
- Height and weight (student athletes only)
- Student's most recent educational institution attended

No other student information is released to non-college or SUNY personnel without consent and written permission, except where the law requires or allows us. Directory exclusion will remain on your SIS record, unless you request removal by notifying us in writing.

Directory exclusion means that the student's name and other information is excluded from the printed directory and college online directories and notices. It also means that the College will not release directory information to third parties without a signed release from the student, except where we are required by law or state/federal authority in accordance with the Family Educational Rights and Privacy Act (FERPA). Please note that directory exclusion may limit us from assisting you in certain ways. Examples:

- You will not receive general campus mailings including mailing for services and facilities provided by the College, except where we are <u>required</u> to provide it by law or policy (email and mail pertaining to your specific record or disposition will not be impacted).
- Your name will not be included in announcements such as honors announcements, dean's list, awards, commencement programs, or other announcements of social, professional, athletic or academic achievements, including the Commencement Program.
- We will not be able to communicate with insurance companies or other vendors where you may be seeking verification, including "good student discounts".

Directory Exclusion does not limit access to your file by authorized individuals nor does it apply to employment information. It does not prevent disclosure of personally identifiable information from a student's record to authorized representatives of federal, state and local agencies, or any of the other exceptions to signed consent found within the FERPA regulations. Information can be released to comply with a judicial order or lawfully executed subpoena. Directory exclusion also does not give a student the right to be anonymous in class or to be removed from class rosters or Blackboard classrooms.
