GE Proposals Discussion	 Agreement to move forward with status quo proposal and discussion of numbered proposals 2-5 (Teams Files). Language: Alternate proposals produced in consultation with the data received, designate Western Civ as integrated into World. Straw vote agreement re: Western Civ redistributed. Summary of discussion points regarding alternative proposals: Discussion of number of credits calculated for each alternative. Question regarding decreasing writing req.; 15 credits are writing/Speaking. Writing Council starting assessment of the writing program per Middle States presentation; premature to cut from program. Goal to set up joint GE and Writing Committee meeting/conversations next academic year suggested by Doug. Communicate, get assessment results – don't wait multiple years. Discussion of Proposal 2. Dan - reserves student choice but is more rigid in terms of 5 categories. Doug/Dan – Concerns expressed about bridging categories and pitting Arts against Humanities. 	

- Carol Humanities, History, Social Sciences student perspective.
- Can only apply a course once to fulfill a category, cannot have a single course fill multiple categories – double dipping.

Discussion of implications of double dipping.

- Frank entire campus on lowest common denominator because of certain programs case by case basis for largest major on campus?
- If no double dipping, categories are kept firm (Binghamton example).
- Carol implications of proposal 2 example no room to raise credit hours for a physics/math double concentration.
- EPC and Senate on getting double dipping out; Carol and Nancy to play it out with Ed student credit scenarios. High credit majors may need to double dip.

Discussion of proposals 2, 3, 4, 5.

- Discussion of 3/6, 4/6, and 5/6 category models. Agreement that 3/6 and 4/6 would not move forward; 5/6 categories discussed as a sustainable model with an average number of credits; Status Quo, 2, and 4 as viable choices, if modeling them with high credit majors shows they work.
- Action: Frank moved to put Status Quo, Proposal 2, and Proposal 4 forward to Senate; Dan seconded. Motion passed unanimously.
