#### **VII. Policy Committee Reports:**

<u>Student Affairs Committee:</u> G. Birren, Chair – Reported that the Student Affairs Committee is still working on selections for the Faculty Senate Memorial Scholarship.

<u>Academic Faculty Affairs Committee:</u> A. Fitz-Gibbon/H. Haines, Chair – Reported that the committee is currently working on personnel policies, as well as the Senate charge that was given to the committee regarding service guidelines.

<u>Educational Policy Committee:</u> C. Widdall, Chair – Reported that the EPC had recently sent out a vetting document regarding requirements in course syllabi (Ch. 220.02 of the Handbook). She had strongly encouraged participation in vetting this document, as it needed input from faculty across campus, however, the committee only received 8 responses.

**<u>SUNY Alternate Senator:</u>** R. Vooris, Chair – Reported on the Spring Plenary, that took place on 4/11/19, at SUNY Potsdam:

- o It was announced at the plenary that Carl H. McCall was stepping down as the Board of Trustees Chairman.
- The majority of the discussion at the plenary focused on SUNY's online initiative; there was a great deal of hesitancy among several of the campuses concerning the online initiative.

• There were 8 resolutions that were passed at the plenary, which will be presented to the Senate on 5/7/19 for endorsement.

- Announced the results of the SGA's elections that recently took place:
  - o Chester Bennett President
  - o Angelo Foster Vice President
  - o Nicolas Estrada Chief Financial Officer
  - The SGA elections were a huge success; a total of 1,668 students voted, which is one of the largest voter turn-out that the campus has ever seen (25% of student community voted).
- Announced that the SGA will be hosting an event for aspiring student leaders this Thursday, 4/25/19, at 5pm at the Alumni House; encouraged faculty members to inform students they may know who could be interested to attend the event.
- Reported that SGA has collaborated with ASC to form a committee that is comprised of students, faculty members, and ASC employees in an effort to prevent further incidents of prejudice/racism in the future.
- Also announced that the SGA is currently underway with its annual Corn Ducky Derby; if anyone is interested, he or she can stop by the SGA office in Corey Union to purchase a duck for \$5.

  - Changes to the SAC, with the amended language from "...student cochair..." to "...student chair..." was adopted by the Senate
- L. MacDonald reminded members that all of the approved changes to Chapter 150.03 of the College Handbook will have to go out to referendum.
