
2. Provide an explanation for the deletion of this program: (attach additional sheets if necessary)

Students who are interested in International Business and Economics should have proficiency in a foreign language not only to make them more marketable when they graduate but we anticipate that students pursuing this concentration will be working in large multinational companies or other types of organizations with international interests. The ability to speak a foreign language will be a prerequisite for these types of positions. The Economics department faculty unanimously voted to require all students who select the concentration in International Business and Economics to complete a foreign language through the 202 level.

Currently, the only difference between the BA and the BS degree in BUSE-IBE is completing a foreign language through the 202 level. By requiring this language proficiency, the faculty are requiring students to complete the BA in Business Economics: Concentration in International Business and Economics. Thus, we are deleting BS degree in Business Economics: Concentration in International Business and Economics.

Dear Isa,

Recently we made a change in our curriculum to offer a BS degree in Economics which may affect your Department. We currently have a very small number of majors (10 or less) who are majoring in Economics with a BA degree. In an attempt to encourage more students into Economics we now want to offer the same exact degree without the language requirement as a BS in Economics. Although we hope this will attract a few more students we do not expect a big surge in our numbers based on past trends. All of our students are already required to take either our Math for Economists class taught by our faculty or take Calculus I and II in your department and those requirements will not change.
