Student Progress in Undergraduate Research Grants (SPUR)

The SUNY Cortland undergraduate research council is offering two SPUR grant opportunities for the spring 2022 semester.

SPUR grants support undergraduate research in all departments and academic disciplines at the College. SPUR grants provide funds to help defray the cost of supplies, small equipment, and other expenses related to data collection or gathering materials required for the successful completion of the project.

Tier 1 Introduction to Research

Tier 1 is designed for students who are new to research and will work on a project primarily conducted by their faculty mentor. While different fields of study may have somewhat different definitions of research, Tier 1 SPUR grants can be used to support an undergraduate student to contribute to an investigation in-progress. For example, the student may conduct a comprehensive literature review or assist with data collection and analysis. Tier 1 SPUR grants are for students with little to no experience with the research process.

Priority is given to student applicants in fields that are less active in campus research, i.e. majors in the humanities; and to students identifying as disabled, first generation and/or from underrepresented racial/ethnic/gender identities in academia.

Students may apply for up to \$200.00 reimbursable through receipts for eligible expenses.

Tier 2 Intermediate Progress in Research

Tier 2 is designed for students who have taken a research methods course, course(s) with required research components or have previous experience working on a research project. Tier 2 SPUR grants are available to support undergraduate students contributing to designing and carrying out a systematic process of inquiry with a faculty mentor. Eligible students are utilizing research skills (beyond the literature review) and preparing to make an intellectual contribution with their own or their mentor's project.

Students may apply for up to \$400.00 reimbursable through receipts for eligible expenses.

Evaluation Criteria for Tier 1 and Tier 2

Applications will be reviewed by the Undergraduate Research Council and evaluated based on the following criteria:

$\hfill \square$ the student has provided two-three measurable outcomes for their learning.
the faculty member has explained the potential merit of the research experience for the student.
the project budget is appropriate for the experience.
the level of faculty supervision and support is clear.

Please note:

- 1. The funds may be used to travel to a field site, library or other off campus location as part of the research process. The SPUR grants are **not** for salary or stipends, nor can they be used to support travel to attend or give presentations at professional conferences or meetings.
- 2. SPUR grants are not intended to support projects that are a part of standard coursework or course assignments nor to support all of the students enrolled in any particular course.
- **3.** Students, if your Tier 1 or Tier 2 project involves data collection with humans, please talk with your faculty mentor about taking the required CITI training in complying with ethical standards and learning about the role of the Institutional Review Board (IRB).
