## IX. Unfinished Business:

- **Review of Governance, Changes to Chapter 150 of The College Handbook** G. Birren, J. Neretich, and K. Sheets opened discussion/debate to the floor of the Faculty Senate
  - G. Birren introduced an amendment to be added to Section 150.04; the amended language is as follows: "Two elected seats representing the interests of full-time lecturers, one to be elected at large from full-time lecturers in the School of Arts and Sciences, and one elected at large from the full-time lecturers or tenure track faculty from the School of Professional Studies or Education. (Approved by President Bitterbaum, June 2009. Updated XXXX 2024) "
    - Concern was raised as to this new language limiting FTL representation
      - It was then further explained that this amendment wouldn't limit FTL representation, as the seat has to be elected by the FTL constituencies
      - Discussion regarding whether changes made throughout Chapter 150 are substantive changes, rather than changes for clarity
        - Most of the changes made were for clarity, as well as to align the language to be compatible with the Board of Trustee's (BOT) language

# X. New Business:

- AFAC Changes to Chapter 220.07 AFAC's revisions to Chapter 220.07 of the College Handbook was introduced to the Faculty Senate; clarifying questions were taken from the floor (*Please find documents attached*)
  - K. Sheets thanked the members of the AFAC for their diligent work on this proposal. Explained many of the changes throughout the document are organizational changes
  - Q. Why is advising being moved from teaching to service?
    - A. To align with the BOT's definition of service
  - Q. Who decides if the service level has been met?

- A. The appropriate personnel committees in the review process
- Q. How will this affect extra service pay?
  - A. Can't speak to this personally, so, unsure of how this would affect extra service pay
- Q. How does this align with other SUNY institutions?
  - A. Many SUNY's model after Cortland
- **EPC Changes to Chapter 415** EPC's revisions to Chapter 415 of the College Handbook was introduced to the Faculty Senate; clarifying questions were taken from the floor (*Please find document attached*)
  - Q. Will these changes go before an external group?
    - A. goes before the Faculty Senate, so, that is considered external input
- **EPC Transfer and Prior Learning Credit** EPC's proposal regarding transfer and prior learning credit was introduced to the Faculty Senate; clarifying questions were taken from the floor (*Please find document attached*)
  - Q. Who wrote this document?
    - A. The EPC and a sub-committee of the EPC comprised of various members from each of the schools
