- o **DEI Board Committee**: DEI Action Plan created at the 2/25/21 BOT meeting by Chancellor Malatras has 5 main goals/implementations:
 - Create an effective process to promote diversity, equity, and inclusion on all SUNY campuses.
 - Campus Climate Surveys
 - Assess progress as pertains to the campus' diversity, equity, and inclusion/measure satisfaction
 - Re-Enroll to Complete Program
 - Created by Chancellor Malatras and implemented on 3/1/21
 - Provides financial and academic support to students who have completed part of a college program, but, did not obtain a degree
 - Strengthen the role of Chief Diversity Officers among SUNY campuses
 - Increase diversity among faculty/staff members on SUNY campuses
 - Diversify UPD
 - Diversify candidate pools, both academic and UUP.

o **Prodi-G Update**:

• There are now a total of 149 Prodi-G representatives from 31 different SUNY campuses

o 1st Amendment Challenges on Campuses:

- There have been an unprecedented rise in racial intolerance across several campuses
 - Creates a very fine line to tread; can't censor individuals due to their 1st amendment rights
