<u>I. Approval of Minutes:</u> The Amended Minutes from March 23rd were approved by the Senate.

II. Chair's Report: G. Birren – Reported that there will be more information coming out in the forthcoming weeks regarding graduation activities; encouraged faculty members to volunteer to help with commencement activities.

<u>**IV. Treasurer's Report:**</u> R. Grantham – Reminded senators to please submit their donations of \$10 to her, if they haven't already done so; senate donations go toward the Faculty Senate's Memorial Scholarship award. All faculty/staff on campus are eligible to donate to the scholarship fund.

V. President's Report: E. Bitterbaum:

- Reported that A total of 660 doses of the Johnson & Johnson Janssen vaccine will be administered by the Cortland County Health Department to SUNY Cortland students; these first 660 does are part of a SUNY system effort to vaccinate as many students as possible before the spring semester ends. SUNY is working with New York State to make additional student-targeted doses available over the next few weeks.
 - Our campus is currently at a 0.24 infection rate
- Waiting for budget
 - There will be no tuition increase for SUNY/CUNY within the next 3 years
- Commencement Committee met this past week
 - Commencement will be held in Lusk Field House and will be live streamed
- Spring athletics have begun in SUNYAC
- Reminded everyone that even though the Cannabis Bill has passed in NYS, cannabis is a Schedule 1 drug, and is therefore not allowed on campus property.
