**<u>I. Approval of Minutes:</u>** The Minutes from November 23<sup>rd</sup> were approved by the Senate.

<u>II. Chair's Report:</u> G. Birren – Reported that the Steering Committee will have a meeting a week or so before the start of the Spring semester to determine whether the Senate will meet virtually or in-person; decision will be dependent upon the status of the Omicron variant.

#### X. New Business:

- **EPC Proposal** Modifications to Sections 340.03 and 350.02 of the College Handbook (*Please find document attached*)
  - Concern as to whether modifications are challenging the character of the student, or is it challenging the incident
    - Motion to cease with clarifying questions and move to discussion: R. Borden
    - 2<sup>nd</sup>: B. Williams
    - Opposition to motion: Yes
    - Vote: 14 aye, 10 nay
    - Since there was not at least a ¾ majority of voting population, motion to discuss is denied; floor remained open to clarifying questions only
  - o Is this now going to be a formalized process, due to the language change?
    - Discussion within academic departments is part of the formal process
  - o Why was the term "alleged" removed from the language on page 2?
    - The instructor making the finding is the first authority in this process; it is not a claim the instructor is making, but rather a finding, and that finding may be challenged in this process
  - Why has the language been changed to include staff members that a student can choose to have present as a witness in their case?

- Staff members include individuals from Advisement/Transition, as well as coaches, etc.; students may feel more comfortable with a particular staff member, rather than a member of the faculty
- Also possible that the student's academic advisor may be a staff member from Advisement/Transition, which is typical for undeclared students
- Concern was raised that not all staff members might be versed in academic situations/pedagogy
- Since the faculty and/or staff member is meant solely to be a witness to the student's hearing, it is not inherent that individual be versed in pedagogy
- The five working days, does that refer to five working days that the meeting with the student should be scheduled, or, does that mean that the meeting with the student must be held within five working days?
  - The student will be notified within five working days of when the meeting will be held
