- o Roll call voting will be implemented only when necessary; a roll call vote can only be implemented by the chair, or if a minimum of 5 senators motion to conduct a roll call vote.

- Resolution 186.05: Resolution Regarding the Importance of Maintaining Effective Shared Governance Practices During Times of Crisis UFS' resolution regarding the importance of maintaining effective shared governance during times of crisis was introduced to the senate and clarifying question were asked.
