<u>College Research Committee</u>: B. Hodges, Chair – On behalf of B. Hodges, J. Ouellette reported that the CRC is in the process of revising the Faculty Research Program RFP for 2018-2019 cycle. The revised application and deadlines will be available soon. General Education Committee: J. MacNamara, Chair:

Assessment – GE 2: Natural Science, GE 3: Social Sciences, GE 5: Western Civilization are being reviewed.

The GE Committee has:

 \cdot Emailed departments to request the formation of rubric sub-committees. GE Committee members will meet with these groups to help advise on rubric formation.

 \cdot Created a schedule for the assessment process with pertinent dates for letters, course sampling, and data to be received for the year-long process.

GE 11 Prejudice and Discrimination – The GE 11 sub-committee submitted a survey to campus last semester. After analyzing the results, they formed a Blackboard Community page for the campus to have access to the survey results and be able to comment. Two open meetings were held regarding the GE 11 discussion. The Blackboard site will remain open for comments until 12-1. At this time, the committee will analyze the data received and determine a recommendation for Faculty Senate.

Critical Thinking/Information Management Competencies:

Meeting with a sub-committee to determine the best way to assess these competencies within the GE program. Laura Davies from English as well as Lauren Stern from the library are working with the committee to determine avenues of assessment.

Curriculog:

Reviewing all courses for inclusion in the GE program.

<u>Graduate Faculty Executive Committee</u>: J. Curtis, Chair – On behalf of J. Curtis, J. Ouellette reported that GFEC is continuing to review and approve the graduate-level curriculum as it comes before the committee. We have also reviewed and voted to update our bylaws, both to reflect changes in existing graduate programs and to better facilitate smooth transitions between committee members. Finally, we will soon be reviewing research and travel grant proposals submitted by graduate students. We encourage faculty to have graduate students with research expenses or who are traveling to present or conduct research to apply.

- With no more amendments from the floor, a vote was then taken to endorse the amended document.
 - Vote: 28 in favor, 0 opposed motion passed.

XI. New Business:

- Resolution for the Senate to endorse the food pantry on campus; a vote was taken and the food pantry was unanimously endorsed (*Please see resolution attached in email.*).
- Resolution in Response to the Regulatory Action Taken by the Charter School Committee of the SUNY Board of Trustees was voted on (on whether to endorse); there were 28 in favor, 2 opposed motion passed (*Please see resolution attached in email.*).

- Chair of EPC, C. Widdall, announced that there will be a document going out to campus for vetting next week in regards to language changes in the AGT (Academic Grievance Tribunal) Manual.
