V. President's Report: E. Bitterbaum:

- All 64 SUNY campuses met with the SUNY Chancellor and discussed budgets for SUNY/CUNY schools
  - The state has enough available funding to finish Van Hoesen; also enough to begin work on science buildings, the library, and Park Center; we will be asking for this money
- Although there has been declining enrollment across SUNY due to legislative push-back, our enrollment numbers are strong
  - COVID has created issues with federal funding
- While there has been a push to mandate faculty/staff vaccinations, SUNY has not yet made any pronouncements regarding this issue
- All new, re-admitted, and transfer students must be fully vaccinated 2 weeks prior before they will be allowed to return to campus for the Spring 2022 semester; deadline to submit proof will be 1/4/22
- Recently returned from fundraising with alumni from the west coast; fundraising efforts are in the form of planned gifts for the university (projected over \$350,000)
  - Plans to meet with alums in Florida next week to continue fundraising efforts

<u>Update from Middle States – C</u>. Van Der Karr and L. MacDonald presented a PowerPoint presentation to provide an overview regarding middle states and strategic planning (*Please find PowerPoint attached*)

- **Call for Nominations, Spring 2021** Additional nominations were accepted from the floor in an effort to fill any remaining vacancies from the Spring 2021 call for nominations (*Please find document attached*).
- **Common Hour Ad-Hoc Committee Proposal:** Guests K. Sheets and H. Doty continued taking clarifying questions from the Senate (*Please find documents attached*)
  - How many courses are in the time slot outlined in the proposal, and how many students are in those same courses?
    - According to the data taken from Spring 2019 (pre-COVID), there would be an average of 75 courses, and around 1900 students in those courses
  - Were students consulted in the drafting of this proposal?

- Yes, an SGA member was on the committee and consulted with SGA eboard back in the spring
- Since the expectation for the Common Hour would be three times a week,
  M,W,F, would it also be the expectation that the various student service offices be suspended during the 1:40-2:50 time slot?
  - It's not concrete it will be M,W,F every single week; what is concrete is that the Common Hour would take place during a non-instructional time slot
  - The Common Hour may even make those student service offices more accessible to students since they wouldn't be in classes during this time slot
- Is there any research available to us from other campuses that currently have a common hour similar to the one proposed?
  - Yes, we will email this information out to the campus with the minutes from today's meeting (*Please find document attached*)
- Who was the initial outreach to when drafting this proposal?
  - Outreach to offices with challenging schedules (i.e. Sciences, athletic students, athletic directors, etc.)
- Some SUNY campuses employ common hour with a 4-day week, has that been considered for this proposal?
  - No, 4-day week was never considered; however, it is worth looking into. It is important to realize that the common hour charge given to us was not a charge to reimagine the campus' daily/weekly schedule
