**I. Approval of Minutes:** The Minutes from May 12<sup>th</sup> were approved by the Senate.

Approval of the Senate Standing Rules: The Senate's standing rules were approved.

**II. Chair's Report:** G. Birren – Welcomed everyone back and introduced herself as this year's chair for the Faculty Senate, while also introducing C. Chatfield as this year's vice chair for the senate. Reported that the senate has a lot to work on this year, and that we will work on items in a prioritized basis.

#### V. President's Report: E. Bitterbaum:

- Reported that, all things considered, the semester has started well

- Announced that our campus will be implementing waste water testing relatively soon; hopefully, by this Friday (9/11/20).

<u>SUNY Senator/ Alternate Senator:</u> R. Vooris/C. Badurek – Reported that former SUNY Chancellor C. Johnson has resigned and that J. Melatrose was appointed to take her place as chancellor; this appointment is what caused the UFS to create the no confidence resolution in the Board of Trustees due to the lack due process.

- Reported that the SGA is in a state of transition right now, as their elections have not yet taken place; SGA elections will be held this Thursday and Friday, with the deadline for voting to be Friday (9/11/20) at 11PM.

## IX. Unfinished Business:

- Call for Nominations, Spring 2020 Nominations that were received via email for the Spring 2020 call were approved by the senate; additional nominations were accepted from the floor in an effort to fill any remaining vacancies (*Please find document attached*).
  - The contested EPC seat representing Professional Studies will go out ballot by the end of this week.

# X. New Business:

- GE Committee Election, Ballot Issue Spring 2020 Last spring semester, the ballot for the contested GE seat had to be reissued due to an error in email lists which has led to some controversy:
  - Past-Presiding Faculty Senate Chair M. DiVita explained the circumstances of that issue, stating that there was confusion among faculty members not understanding that they were required to re-cast their votes, even though they may have already voted in the initial ballot (which was voided before the initial ballot deadline), and therefore a third ballot was being considered to go out to campus; the Faculty Senate Steering Committee was under the impression that the results of the 2<sup>nd</sup> ballot should stand, as the results of that ballot had already been published and confirmation had already been sent out to the winning candidate.
  - On behalf of former Senate Chairs K. Alwes, K. Lawrence, and J. Ouellette, as well as on behalf of L. Davies, and A. Harbin, M. Lessig addressed the senate on the controversy of sending out a 3<sup>rd</sup> ballot, explaining that due to the clarity of the instructions included in the 2<sup>nd</sup> corrected ballot, the failure to follow such instructions should not be grounds for voiding an election unless the Senate is prepared to void every future election in which an eligible voter fails to carefully read their email.
    - M. Lessig thanked the senate for allowing him to address the senate on this issue.
      - With all things being considered, the senate is not taking any action to send out a  $3^{rd}$  ballot; the results of the  $2^{nd}$  corrected ballot stands.
- UFS Resolution: Vote of No Confidence in Politically Appointed Members of SUNY Board of Trustees (*Please find document attached in email*) SUNY Senator R. Vooris explained the reasoning behind this resolution, stating that the UFS' objection is to the process that was implemented to install the new SUNY Chancellor; instead of there being a nation-wide search for

the next chancellor following the resignation of C. Johnson, J. Melatrose was simply appointed by Governor A. Cuomo, rather than by following due process.
