I. Approval of Minutes: The Minutes from February 27th were approved by the Senate.

II. Chair's Report: K. Lawrence:

- Announced that the Spring 2024 Call for Nominations is now open to receive nominations; we have already received several for both committee and senator vacancies
 - o Deadline to submit nominations will be 3/29/24 at 4PM
 - Reminded everyone when submitting a nomination on behalf of another individual to please be sure to have that other individual's consent prior to submitting the nomination; self-nominations are also acceptable
 - Reminded everyone that it is acceptable to have more than one nominee for a
 particular vacancy; in this case, the seat becomes contested and will go out to
 ballot to the appropriate constituencies following the close of nominations
 - Thanked P. Schroeder for her assistance in submitting several nominations in an effort to fill vacancies
- Reminded everyone that the Faculty Senate's open meeting is scheduled for 4/16/24 from 1:15PM-2:30PM in the Corey Union Exhibition Lounge where the discussion will focus on the Review of Governance
 - o The last Senate meeting of the semester is scheduled for Tuesday, 4/30/24; it is at this meeting that the Senate will vote on the ROG Committee's amendments to Chapter 150 of The College Handbook
 - If these amendments are approved by the Faculty Senate, then the amendments will go out to referendum
- K. Lawrence reported the following statements on behalf of L. Lopez-Janove:
 - The campus climate closed last Saturday. We had a 5% student and 20% employee response rates. I'm announcing the recipients of the incentives before the end of the week. I'm working with institutional research to get the data analyzed and reported out to campus as soon as possible
 - o Ramadan, the Islamic month of fasting, takes place from March 10 and ends on April 9 (give or take 1 or 2 days). A communicator was sent out listing ways we can be supportive for those who observe. The email contains a Cortland Auxiliary Services link for students to request meals at the end of their daily fast. The International Office set up a private prayer room with prayer rugs that any

students can use, anytime Monday through Friday from 8:15am to 4:15pm in Old Main, Room 219 (2nd floor)

- K. Lawrence reported that she met with HR this past week to discuss the changes made this past Fall 2023 semester to the procedures during the hiring process
 - There is a required workshop that K. Lawrence encouraged everyone to complete sooner rather than later, in part due to the beneficial information gained through the workshop

III. Vice Chair/Secretary's Report: D. Harms:

- Presented slate of vacancies to the Faculty Senate for the Spring 2024 Call for Nominations
 - o Announced nominations that were submitted via email to fill senator and committee vacancies (*Please find documents attached*).

V. President's Report: E. Bitterbaum:

- Reported on his travels to California over Spring Break to meet with alumni
- Reported on the FAFSA situation; due to the disruption the issues with FAFSA have caused, the SUNY Chancellor has altered deadlines to 5/15/24 and 6/1/24
- Discussed the down-sizing of academic programs within various SUNY's due to lack of student enrollment; in some cases, there have been freezes due to the decline in students (Potsdam and Geneseo)
- Discussed student health and well-being; there is a new initiative within the SUNY system that requires each SUNY campus to have a homeless liaison
- SUNY received \$10,000 transportation grant
- K-12 receiving 2 billion; Higher Ed receiving 54 million
- New initiative for Amazon pick-up boxes across several campuses; we are currently looking into it
- A. McClellan reported on the current Course Teacher Evaluation situation
 - At this time, we still don't have a contract; in the meantime, we will continue using the Legacy System
 - o In the process of meeting with department deans and associate deans in an effort to establish a workable timeframe
 - o Email will be sent out by the end of the week with additional details

IX. Unfinished Business:

- UFS Resolution 196-01-1: Ensuring Non-Discrimination, Enhancing Campus Discussion/ debate was opened to the floor of the Senate
 - B. Williams encouraged opposition from fellow Senate members on this resolution, as it
 presents a very one-sided view against Israel; the goal is to promote free speech on
 campus, rather than to stifle it
 - Vote: 21, 1
 - Resolution endorsed by the Senate
- UFS Resolution 196-03-1: Addressing Artificial Intelligence (AI) in the SUNY Workplace Discussion/ debate was opened to the floor of the Senate
 - o Vote: Unanimously endorsed by the Senate
- **UFS Resolution 196-04-1: Excelsior Scholarship Review** Discussion/ debate was opened to the floor of the Senate
 - o Vote: Unanimously endorsed by the Senate
- UFS Resolution 196-05-1: Opposition to Mandated Purchases from SUNY Preferred Vendor Corcraft Discussion/ debate was opened to the floor of the Senate
 - Vote: Unanimously endorsed by the Senate
- UFS Resolution 196-06-1: Process for Professional Staff Advancement Discussion/ debate was opened to the floor of the Senate
 - Vote: Unanimously endorsed by the Senate

- **EPC Revisions to Course Withdrawal Policies** Discussion/ debate was opened to the floor of the Senate
 - o On Behalf of E. Edlund, R. Davis made a motion to withdraw the proposal from the floor, so that the EPC can take the proposal back to committee for further revisions
 - No opposition; proposal will go back to the committee and be re-introduced to the Senate at a later date
