- Reported that the ROG Committee has been meeting regularly and are moving along with their work; the committee has recently reached out to all chairs of the Faculty Senate's standing committees. ROG will present their work to the Senate sometime in the Spring 2024 semester
- Announced that the covering over the new lighting outside of Van Hoesen Hall has added to the improvement/safety on campus

- P. Arenas also thanked the Faculty Senate for allowing him to serve on the Senate as a student representative; commented that while it was an eye-opening and enjoyable experience for him, Faculty Senate will have a new student representative in the Spring 2024 semester, as he will be unable to serve due to scheduling conflicts. K. Lawrence acknowledged the SGA representatives for their service and the assembled Senate applauded their efforts. She encouraged him to return next year and serve again if his schedule allows

IX. Unfinished Business:

- Call for Nominations, Spring 2023 See V. Chair Report
- **EPC Policy Revision Proposal** Policy Revision to Support Undergraduate/Graduate Combined Programs was brought to the floor of the Senate for discussion (*Please find document attached*)
 - C. Van Der Karr spoke to the policy as being in alignment with SUNY policies; mentioned that both the Financial Aid and Registrar's Office were contacted when working on this policy
 - C. Widdall commented that this is just a beginning policy; there will more than likely be changes/alterations to the policy
 - R. Borden commented that, in his opinion, the policy seems counter-productive in that the policy creates an inequity for certain students; depending on when students enter the program, this policy makes it so that some students have the opportunity to "double-dip" and receive both undergraduate and graduate credit while those students who enter the program later would not receive both undergraduate and graduate credit
 - Discussion ensued
 - E. Edlund commented that while he is supportive of the proposal, he too has concerns about the inequity the policy potentially creates for students; also commented that he'd like to see the proposal possibly expanded so that all students who enter the program, regardless of when they entered it, can reap the same benefits
 - Discussion ensued
 - K. Sheets inquired about what constitutes senior year for a student; is it solely based upon credit hours?
 - C. Van Der Karr responded that the status of a being in his/her senior is a combination of credit hours, pre-requisites, etc. and is also based on how much of the actual degree the student has completed, rather than just on credit hours alone
 - C. Widdall motioned that the Senate cease with debate and bring the proposal to a vote
 - 2^{nd} : S. Daman
 - Vote to cease debate: In favor: 16; Opposed: 6; greater than 2/3 approval debate has ended
 - Vote to accept proposal: In favor: 17; Opposed: 3
 Proposal accepted by the Senate

X. New Business:

- Handbook Revision for Generative AI K. Ahern introduced handbook revision to the Senate; clarifying questions were then opened to the floor
 - \circ Motion to end clarifying questions and move to discussion/debate: S. Daman
 - 2^{nd} : J. Neretich
 - Vote: In Favor: 18; Opposed: 2; discussion opened to the floor
 - R. Borden raised the concern that the proposed revision is counter-productive; students can't submit work that isn't their own as their own
 - A. Blavos commented that if this revision is voted down, it will prevent faculty from assigning work where the students are required to use Generative A.I.; in those cases, the students are not submitting the work completed using the Generative A.I. as their own, but rather as a research tool
 - Further discussion ensued concerning students use of A.I. in their research processes, and whether or not the use of Generative A.I. as a research tool would go against this revision
