**<u>I. Approval of Minutes:</u>** The amended Minutes from November 7<sup>th</sup> were approved by the Senate.

**II. Chair's Report:** K. Lawrence:

- Announced that due to the ongoing issues with advising loads across several academic departments, there will be an ad-hoc committee formed to address said issues; passed around sign-up sheet for those interested in serving
  - Anyone interested in participating please contact A. DeChellis or K. Lawrence
- Reported on faculty search committee process as this was a topic that was brought before the Senate at the 11/7/23 meeting
  - Reported that she had been in contact with HR last week regarding the issue and it was explained that the change in reference checks was a very temporary change; the process regarding faculty position searches has returned to its original order for reference checks to be completed before invitations for campus interviews
  - Lawrence also reported HR is preparing materials and planning training workshops for faculty searches. These should begin in the Spring Semester. FS will be providing announcements when possible and appropriate, regarding any HR workshops and changes, just to try to reach as many as possible with this information.
- Reported that the outdoor lighting across campus has been improved; Lawrence acknowledged and thanked all those involved in getting the lighting near the new Van Hoesen Hall construction added so quickly. The Campus Police Department and the Facilities Office were extremely helpful.
- Recognized K. Ahern to address the Senate on the A.I. Committee
  - K. Ahern: the A.I. Committee has been meeting regularly, and has created a proposal to present before the Senate Steering Committee on 11/28/23 with the intention of then presenting to the Senate at the 12/5/23 meeting
- Announced that Chief Diversity Officer L. Lopez-Janove has intentions to present to the Senate during the Spring 2024 semester; in the meantime, watch for an email from Lorraine containing a Call for Participation in planning the Schedule for Events and Programming during Black History Month

- Announced that the ROG Committee has been meeting and beginning work over the past two weeks.
- Proposed the idea of a week-long Thanksgiving Break for future academic calendars, as the majority of students leave beforehand, some as early as a week before the vacation officially starts. This makes it especially hard on Faculty who are trying to hold effective classes when only a couple of students attend. Faculty are on campus to teach but it challenges the role of traditional pedagogical methods.
  - Discussion ensued, noting that in order to feasibly have a week-long Thanksgiving Break, either Fall Break would have to be taken away or the semesters made longer
    - It was also noted that the removal of Fall Break would not be conducive to students' mental/emotional health, as the removal of Fall Break statistically shows that not having the mid-semester break can be more challenging to first year students who are experiencing mental health challenges.
  - P. Arras proposed perhaps giving the option of online instruction during the week of Thanksgiving
    - S. Daman noted that leeway for academic faculty would in turn further the inequity between academic faculty and professional/classified faculty, as the latter already only has Thanksgiving Day off rather than the 3 full days that academic faculty currently receive
- Reported plans to extend invitations during our Spring meetings to several people representing offices and programs with relevant information for Senators.

- Announced nominations that were submitted via email to fill senator and committee vacancies; we did not receive any additional nominations at this time (*Please find documents attached*).
  - Remaining vacancies are as follows:
    - Senator vacancies (7 total): 1 seat representing Math/Science, 1 seat representing Social/Behavioral Sciences, 1 seat representing FTL Education OR Professional Studies, 2 seats representing Professional Faculty, 1 seat representing Graduate Faculty, and 1 seat representing Part-Time Faculty
    - Committee vacancies (2 total): PFAC: 1 (unexpired term) seat representing Academic Affairs, CRC: 1(unexpired term vacant SP 2024 ONLY) seat representing Math/Science

- Questions were raised as to who initiated the "request for this policy". D. Harms, speaking from his position as a UUP executive. stated the request did not come from the Union and referenced the Student Manifesto of years prior.

- **EPC Policy Revision Proposal** Policy Revision to Support Undergraduate/Graduate Combined Programs was introduced to the Senate by C.     - A. Purpose of this program is to financially benefit the student
  - Q. What happens if a student does not complete the Graduate level of the degree? Will the student still receive the Undergraduate degree?
    - A. The student will have completed just the Bachelor's Degree
  - Q. Is the student responsible for the 4+1 application fee?
    - A. The student does not have to pay application fee
