Learning Outcomes

As a result of participating in COR 101, the new first-year student at SUNY Cortland will be able to:

Course Requirements:

1. Attend at least five campus/community events.

All students are required to attend 5 campus/community events over the course of the semester. Events must be completed periodically throughout the course of the semester. Due dates are listed in the Weekly Course Schedule. Past due dates will lose 5 points for each day late. Students should select 1 one of each of the following categories:

- Cultural
- Athletic Lecture/Program
- Academic club
- Student choice

To demonstrate attendance at an event, students will post a selfie of themselves at an event and submit it through blackboard.

2. Written Material

Students will be expected to complete 6-12 pages of written material over the course of this semester.

3. Become proficient using myRedDragon and other campus technology tools.

Students receive important campus information via myRedDragon. It is important students review their email on a daily basis. Students should also become familiar with BlackBoard, DegreeWorks, and the SUNY Cortland website.

4. Attend class and participate with class discussion and activities.

Attendance is required at each class. You are permitted one unexcused absence. If you must be absent, notify the instructor of the date of absence and reason before missing that class. Illness should be reported to the in a timely manner. It is the responsibility of the student to make up all missed work, to contact the instructor, and to turn in assignments, regardless of absence.

5. Completion of Other Coursework (Assignments)

In addition to written coursework and active participation, assignments will be given out throughout the semester in conjunction with material being taught. It is expected that the student will complete these materials. Material may be completed in class or outside of class time

Grading

COR 101 is graded on a scale of E (failing) to A (superior) and is worth one earned credit towards the students overall degree progress. Instructors may elect to use a grading scale that meets their needs for their class. We recommend compiling grades on either a 100 or 1,000 point scale.
